Pursuant to the Georgia Constitution Article IX, Section II, Paragraph 1, et seq. and Georgia Constitution Article IX, Section II, Paragraph IV and Chapter Sixty-Six of Title Thirty-Six of the Official Code of Georgia Annotated (O.C.G.A. §36-66-1 et seq.) and The Land Use Procedures and Standards Ordinance of Gilmer County, Georgia, the Gilmer County Board of Commissioners propose to amend Chapter 62, Article II “Land Use Ordinance,” of the Code of Ordinances of Gilmer County, Georgia, so as to change various provisions related to the Land Use Ordinance; to provide for an effective date; to repeal conflicting laws; and for such other purposes.
